It is understood that there will be no additional charge for the installation of the service line pipe (up to 75 LF), residential and small commercial meters, regulator, piping and fittings. Initial costs of large industrial meters will be the responsibility of the applicant as well as replacement costs due to improper usage. All applicants will be required to furnish the interior piping, installed to meet the standard of the International Fuel Gas Code (a copy being on file in the office of City Clerk for inspection), and the manifold piping, which shall not be less than 1 (one) inch in size, shall extend not less than 8 (eight) inches beyond the outside building wall. The manifold pipe shall be rigid black iron pipe and shall be rigidly fastened to the building in such a manner which will permit making the outside connection without disturbing the inside piping.

As an inducement for the City of Perryville to accept this application, the applicant

1. Agrees to pay for all gas used on said premises at the rates provided by ordinance of the City.
2. Hereby grants an easement over said premises in favor of the City of Perryville, Missouri for the purpose of laying, maintaining, metering, repairing and replacing the natural gas line servicing the premises or the adjoining premises.
3. Applicant hereby agrees to indemnify and hold harmless the City, its agents and employees from any claim, demand or injury arising from the construction, installation, and service of or to gas lines, service lines, and all appurtenances thereto, including the settling of any trench. The applicant acknowledges that the City is under no obligation to fill or level settled trenches.
4. Agrees that the City is under no obligation, nor can it be held liable for any damages for not service said premises but it is understood and agreed that the above connection fee will be refunded upon applicant's request if natural gas service is not available to said premises within 6 (six) months from this date.
5. Agrees to file an application with the City for the installation of any gas equipment, and not to use such equipment until it has been inspected by the City.
6. Agrees that the City assumes no responsibility for the interruption of service and the City shall have the right to discontinue service to said property for any of the following reasons:
 - For the reason when the safety of the general public is endangered or public convenience and necessity requires.
 - Defective piping and equipment on my premises.
 - Company maintenance and construction operations.
 - Violation of the City Rules and Regulations and failure to pay charges for service rendered.
