STEP 1: Completion of prerequisite skills (listed below) by appointment. 573-547-7275

STEP 2: Completion of 6 hour online training portion prior to first day of class

STEP 3: Successful completion of in-person training & written exam on training weekend.

Prerequisites: *Min. age: 15 years; Swim 300 yards continuously; Tread water for 2 minutes using only the legs; Complete a timed event within 1:40 seconds by starting in the water swimming 20 yards surface dive to a depth of 7 to 10 ft. to retrieve a 10-pound object return to the surface and swim 20 yards on the back to return to the starting point exit the water without using steps or a ladder. You will need to take one final written exam consisting of 50 questions and score a minimum of 80%. The online portion of this course must be completed prior to the prerequisite testing.*
